PROGRAM DESCRIPTION

Expanded Function Dental Auxiliary Program

Students will develop self-evaluation skills, an understanding of the Ohio State Dental Board Rules and Laws as they pertain to EFDAs, as well as professionalism and critical thinking in dentistry. January through April students will complete over 100 hours of face-to-face pre-clinical didactic/laboratory instruction on either Monday's or Thursdays. Emphasis is placed on sealants, amalgam restorations, composite restorations and temporary restorations. May through July students will complete 80 hours of clinical requirements under the supervision of their employer(s)-licensed dentist(s). Pre-clinical proficiency must be obtained prior to proceeding to patient treatment. Proficiency is deemed by passing pre-clinical weekly competencies, final competency examination, and instructor recommendation.
