## October 11, 2018

The regular Meeting of the Hocking College Board of Trustees was held Monday, October 11, 2018, at The Lodge of Hocking College, Nelsonville, Ohio.

Administrators attending: Dr. Betty Young, President; Mr. Jeff Daubenmire, Chief-of-Staff; Ms. Jacqueline Hagerott, Vice President of Campus and Community Relations/Ombudsman; Jeff White, Vice President of Student Experience and Human Resources; Mr. Tim Brunicardi, Executive Director of Marketing, Public and Community Relations; Denise O'Donnell, Vice President of Financial Services / CFO; Steve Wilson, CIO Information Technology.

Additional attendees: Staff, Bargaining Units Representatives, and media.

## **CALL TO ORDER**

Chairman Johnson called the meeting to order at 6:02 pm.

#### **ROLL CALL**

Sheree Cunningham, Board Secretary, called the roll:

Board members present: Trustees Jeanie Addington, Mike Brooks, Stuart Brooks, Mike Budzik, Leon Forte', Andrew Stone, and Chairman Johnson.

Board members absent: Trustees Dan Fischer and Ben Mitchell

Members present constitute quorum.

#### **ELECTION OF OFFICERS**

<u>Chairman</u> – Chairman Tom Johnson nominated Trustee Andrew Stone for Chairman of the Board for 2018-2019. Trustee Mike Brooks seconded the motion. There were no further nominations. The motion was unanimously approved.

<u>Vice Chair</u> – Trustee Tom Johnson nominated Trustee Dan Fischer for Vice Chair. There were no further nominations. Trustee Stuart Brooks seconded the motion which was unanimously approved.

<u>Treasurer</u> – Trustee Mike Brooks made a motion to nominate Denise O'Donnell for Treasurer. The motion was seconded by Trustee Tom Johnson and unanimously approved.

<u>Secretary</u> – Trustee Andrew Stone nominated Sheree Cunningham as Secretary. The motion was seconded by Trustee Leon Forte' and unanimously approved.

### **OATH OF OFFICE**

Chairman Stone reported that the Caucus of the School Board Presidents met and reappointed Trustee Tom Johnson and Trustee Jeanette Addington. Terms will expire on August 31, 2021.

Chairman Stone invited Trustee Johnson to stand and take the Oath of Office. He then invited Trustee Jeanette to stand and take the Oath of Office.

## **APPROVAL OF MINUTES**

Chairman Stone then took over the meeting as the new Chairman of the Hocking College Board of Trustees. Chairman Stone asked if there were any changes to the minutes from the August 27, 2018, regular meeting. A motion was made by Trustee Stuart Brooks and seconded by Trustee Leon Forte' to approve the August 27, 2018, Board of Trustees minutes. The motion was unanimously approved.

### PRESIDENT'S REPORT

Dr. Young's report consisted of the following:

- <u>Award</u> Dr. Young reported that Chairman Stone received the 2018 Maureen
   C. Grady Award for Special Achievement by the Ohio Association of Community Colleges.
- <u>Etiquette Dinners</u> Dr. Young stated the Etiquette Dinners for first year students are going very well. Students learn to bring their business cards, arrive in business dress attire, are pre-assigned to tables, learn to speak with strangers, and learn which table service to use with each course. The dinners have been a success.
- Homecoming 2018 Dr. Young commented this is the first year for the School of Natural Resources Hall of Fame. Honorary inductees included: Kenneth Temple, Mike Taylor, Gary Obermiller, Mike Miller, and Pat Quackenbush.

Hocking College won their Homecoming Game.

Requirements for the Homecoming Queen and King are to earn the most money for the cause selected for the year. This year's money raised went to the Student Emergency Fund. The current Queen and King earned a total of \$800.00, which is very impressive.

The Sandy Tar Band also performed during the homecoming weekend. Dr. Young state that the weekend was full of activities.

Release of Bald Eagle – Dr. Young commented in May of this year, our Nature
Center received a call about a juvenile bald eagle that a Department of
Transportation worker found while mowing along Route 33. The eagle was
emaciated, in distress and weak. The bird was taken to the Ohio Wildlife Center

- in Columbus for treatment. On Thursday, September 20, 2018, the Ohio Wildlife Center returned the eagle to the Hocking College Campus, where the bird was released back into the wild. It was quite an event. Our own in-house photographer, Samantha Crist, took the picture that was used in the papers. The article made the US News.
- NACCE (National Association for Community College Entrepreneurship
  Conference) Dr. Young stated she, Michelle Robinson and Micah Covert
  attended the conference in Fort Worth, TX. Dr. Young was one of the key note
  speakers and the College was also selected to do a presentation on
  Entrepreneurship. She commented after the presentation several institutions
  would like to visit our campus. Dr. Young played a video of what they presented
  to the conference. She commented that Sean Terrell has done tremendous job.
- Chancellor John Carey's Hocking College Visit Chancellor Carey was a guest at Hocking College on September 5, 2018. He visited the College where he was given a tour of our Career and University Center. One of the goals is to have each student have a financial plan, job resume and a developed plan once they graduate. Students create resumes and have their resume critiqued and have mock interviews. By the time they graduate, they are to have a plan to pay off student debt and have a plan for retirement. Sean Terrell discussed the Ohio Internship program. Lastly, there was discussion surrounding Hocking College's mental health program and plans for new training in Mental Health First Aid.
- <u>Dental Hygiene</u> Dr. Young stated she had hoped to have this month's board meeting at the Perry Campus. However, we do not have our final occupancy permit. She pointed out the power point picture of the state of the art dental lab. The CODA Dental Hygiene Site Visit will be next week. She stated the Program Manager, Alaina Himes, who was hired a year ago has done a great job with starting the program.
- Animal Assisted Therapy The occupancy permit for the Animal Assisted
  Therapy building should be received any day now. Dr. Young distributed a
  brochure for a fundraising campaign for the program.
- Lab Science Program On October 4, 2018, there was a preliminary walk-thru with individuals from Columbus for the cannabis lab. Everything is looking great. Quidel is assisting us with the required software. We are piloting the software with them. Trustee Johnson asked about pricing. The lab should be ready by the first of November. The first two growers are growing and they will be harvesting late 2018 / early 2019. Dr. Young reported next fall there will be students in the academic program for cannabis technicians. Some of these students are currently taking preliminary courses. Trustee Forte' had questions regarding branding. Dr. Young stated that we are moving full speed ahead and are the first to market. Currently, we are the only lab in the State of Ohio. There will be others to come to market, but it is a niche market. Hocking has a dedicated lab and will also have Dr. Cachet to support this venture.
- <u>Campus Projects</u> The Bridge from John Light Hall to the Visual Arts Studio and Natural Resources has been completed. They were seeding today.
- <u>Therapeutic Massage</u> In the past, Massage Therapy and Physical Therapy shared a lab. Now each program has their own dedicated lab. The final item

- will be to hang the curtains which came in today. This will assist in recruiting students. Ultimately, we will reopen the spa program when renovations to the hotel are complete.
- On October 16, 2018 The <u>Governor's Office Opiate Task Force Conference</u> "Why Not Us?" will be held at the Student Center.
- Appalachian Recovery Project On October 15, 2018, the College will be hosting the Public Forum for the "Appalachian Recovery Project." Hocking College's role in the project is workforce development. The goal is to keep the community apprised of what is going on with the old prison.
- <u>Cannabis Lab</u> Dr. Young stated the College would like to go door-to-door to explain the cannabis lab to the neighbors near the Sylvania Building. After meeting the neighbors, a ribbon cutting for the whole community will take place. She stated the goal is to alleviate concerns from the community. The security is very high for the lab, and the amounts of cannabis on the site will be very small. It is only for testing and research.
- ACCT 2018 Conference Dr. Young reported at the upcoming ACCT conference, Trustees Addington, Johnson, and Mitchell will be doing a conference presentation along with Dr. Davis and herself. The title of the conference is "Academic Success: Initiatives for Non-Academic Support Leaders."
- Educause Dr. Young reported she will be on the panel at the Cengage
  Conference for Educause. The conference will be held in Denver, Colorado and
  will be no cost the College. She stated that she is very excited to be selected
  for the panel.

<u>Career and University Center</u> – Mrs. Danita Reynolds gave an in-depth report on the Career and University Center. She highlighted the following: Career readiness and financial planning, 24 hours of personal development, which included the etiquette dinners, Clothing Closet, and the Career Fair which is now part of the curriculum. Dr. Young commented that the faculty is instrumental in getting their students to the Career Fair.

#### FINANCE COMMITTEE REPORT

Ms. O'Donnell reported that we are looking forward to having the Auditors on Campus the week of November 26, 2018.

## **FACILITIES COMMITTEE REPORT**

Trustee Budzik gave a detailed report on projects that have been completed since June 2018. Some of these projects are as follows: Washington Hall, HCEI Downour, Fermentation Science, Dining Services, Lake Snowden, etc. He also commented that bids will be going out in January for the equine, hotel and police station projects. Trustee Budzik then reported that Hocking College students will be building a storage facility for a Community Service project for Habitat for Humanity, which former Trustee Tucker is involved in. He commented students are doing fine work and it is a great learning experience for them.

## PERSONNEL AND COMMUNITY RELATIONS COMMITTEE REPORT

Ms. Hagerott gave an in-depth report on Cengage, which is a company who has electronic resources for students. She commented that Cengage has over 2000 titles of books on-line. Ms. Hagerott reported on initial savings by using Cengage resources. She stated currently there are 121 students in the trial program for this Fall with a savings of \$62,678. There will be a one cost fee per semester for all learning materials. The entire project will be launched in Fall of 2019. Dr. Young stated kudos to Jacqui who has worked very hard on this project.

## CHAIRMAN'S REPORT

Chairman Stone reported on the following:

- <u>Committee Appointments</u> Trustee Johnson will be appointed to the Personnel and Community Relations Committee. Trustee Fischer will remain on the Academic Affairs Committee.
